As a statutory consultee, The Coal Authority has a duty to respond to planning applications and development plans in order to protect the public and the environment in mining areas.

Our records indicate that within the Bassetlaw District area there are recorded coal mining features present at surface and shallow depth including; mine entries, fissures and breaklines and reported surface hazards. These features may pose a potential risk to surface stability and public safety.

It is noted that this current consultation relates to the Community Infrastructure Levy Draft Charging Schedule and the two changes proposed. I can confirm that the Planning team at the Coal Authority have no specific comments to make in respect of this consultation.

The Bassetlaw Community Infrastructure Levy Draft Charging Schedule will be subject to an independent examination to be conducted by the Planning Inspectorate. The examination process is now under the Planning Inspectorateâ€[™]s control.

The appointed Examiner will examine if the Bassetlaw Community Infrastructure Levy Draft Charging Schedule meets relevant legislative requirements. The Examiner will review representations previously made on the document and will consider local evidence. The examination process may involve hearing sessions where those invited to attend will have the opportunity to respond to matters raised by the Examiner.

In accordance with Regulation 16 the Council is proposing two changes to the charging schedule. In accordance with Regulation 19(4) attached is the statement of modifications submitted to the Secretary of State.
