#### Document Title:

Bassetlaw Local Plan 2020-2038: Main Modifications

#### Subject Matter:

The Bassetlaw Local Plan sets out the broad spatial planning and policy framework for Bassetlaw District up to 2038. The Main Modifications to the Bassetlaw Local Plan are those deemed by the Local Plan Planning Inspectors to be necessary to make the Local Plan legally compliant and sound.

#### Period for submission of representations:

Representations are invited on the Bassetlaw Local Plan 2020-2038: Main Modifications and Policies Map Modifications, the Sustainability Appraisal and Habitats Regulations Assessment for a period of six weeks, from the 22 August 2023 to 5pm on the 3 October 2023. Representations received after this time will not be accepted. This statement provides details on how to make comments.

This should identify which Main Modification the representation refers to.
